Part III. Measurement of Outcomes

Partnerships

Danish Architecture Center is based on a public/private partnership between three ministries – the Ministry of Industry, Business and Financial Affairs, the Ministry of Culture, and the Ministry of Social Affairs and Housing – and the civil society philanthropic association Realdania.

Danish Architecture Center is also a part of the **Planet Copenhagen** network working for Copenhagen to achieve first place on the list of most sustainable tourist destinations in Europe in the eyes of the tourists.

Furthermore, DAC is part of the **ESG network** at the Danish Chamber of Commerce.

Copenhagen Municipality's exhibition spaces and other Copenhagen area museums

Many exhibition spaces and museums are working towards more circularity in exhibition design. DAC's pragmatic and systematic approach to data collection and procurement is widely regarded as an example and source of inspiration. Thus, DAC staff has been invited to share methods on several occasions, and DAC spreadsheets are used as templates for others.

DAC's partners for exhibitions and debates/talks are Denmark's leading design studios, architects, scholars, civil servants and politicians in the field of sustainability in the built environment. The Strategic Urban Governance program facilitates networks and educates local governments (municipality officials and politicians) on sustainable development.
